This statement is filed pursuant to Rule 13d-2(b) with respect to the Common Stock, \$.01 par value (the Common Stock ), of Exact Sciences Corporation (the Issuer ) beneficially owned by the Reporting Persons specified herein as of December 31, 2006, and amends and supplements the Schedule 13G dated December 27, 2005, as previously amended on February 14, 2006 and filed by the Reporting Persons (collectively, the Schedule 13G ). Except as set forth herein, the Schedule 13G is unmodified.

The names of the persons filing this statement on Schedule 13G are (collectively, the Reporting Persons ): Paloma International L.P., a Delaware limited partnership ( Paloma ), S. Donald Sussman ( Mr. Sussman ), MAK Capital One L.L.C., a Delaware limited liability company ( MAK Capital ), MAK Capital Fund LP, a Bermuda limited partnership ( MAK Fund ), and Michael A. Kaufman ( Mr. Kaufman ).

### **Item 4. Ownership.**

The Reporting Persons collectively beneficially own 2,240,696 shares of Common Stock.
