  - (3) The security converts to common stock on a one-for-one basis.
  - (4) Cumulative phantom units accumulated by director during his Board tenure.

- (5) There were 25.3 phantom stock units omitted from the reporting person's Form 4 filed May 3, 2005 (i.e., the number of units should have been 109.6 rather than 84.3 as originally reported).
