On July 13, 2005, the reporting person was awarded a contingent, performance based grant for an opportunity to earn 21,696 restricted shares. This opportunity was subject to the satisfaction of certain performance criteria based upon specified peer groups. Depending upon (1) the issuer's performance within the peer groups, the reporting person could earn some, all or none of the shares. The issuer's actual performance resulted in 12,584 restricted shares being granted, which vest as follows: 4,194 on March 19, 2007, 4,195 on January 1, 2008 and 4,195 on January 1, 2009.

On July 13, 2005, the reporting person was awarded a contingent, performance based grant of 38,639 stock options, which were subject to the satisfaction of certain performance criteria based upon specified peer groups. Depending upon the issuer's performance within the (2) peer groups, the reporting person could earn some, all or none of the options. The issuer's actual performance resulted in options to purchase 22,411 shares being earned, which vest as follows: 7,470 on March 19, 2007, 7,470 on January 1, 2008 and 7,471 on January 1, 2009.
