Introductory Statement

Everest Reinsurance Holdings, Inc., an indirect wholly-owned subsidiary of Group, has reported the exchange of 9,719,971 Common Shares of Group to Everest Preferred International Holdings, Ltd., a wholly-owned subsidiary of Group, in exchange for Preferred Shares of Everest Preferred International Holdings, Ltd., as of December 22, 2015. After the exchange, Everest Reinsurance Holdings, Inc. no longer holds any shares or has any ownership interest in Group.
