Pursuant to the non-qualified deferred compensation plan, payouts can occur for up to 15 years. Amounts held in the phantom stock accounts would be amortized over that period unless directed otherwise by the participant.
- (3) Phantom share balance reflects correction to previously estimated shares acquired through the reinvestment of dividends in the Company's deferred compensation plan, which were voluntarily reported.
