(a) The Frequency Electronics Inc. 401(k) Plan ("401(k) Plan"), and the Frequency Electronics Inc. Employee Stock Ownership Plan ("ESOP Plan") are subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). Delaware Charter Guarantee & Trust Company dba Principal Trust Company acts as the Trustee of the 401(k) Plan Trust and the ESOP Plan Trust (collectively, the "Trusts"). As of December 31, 2013, 401(k) Plan Trust held 452,338 shares of the Issuer's common stock and the ESOP Plan Trust held 402,854 shares of the Issuer's common stock for an aggregate of 855,192 shares of the Issuer's common stock. The securities reported include all shares held of record by the Trustee. The Trustee follows the directions of the Employer, Frequency Electronics Inc. (the "Employer"), or other parties designated in the trust agreement between the Employer and the Trustee, with respect to voting and disposition of shares. The Trustee, however, is subject to fiduciary duties under ERISA. The Trustee disclaims beneficial ownership of the shares of common stock that are the subject of this Schedule 13G.

(b) The 855,192 shares of common stock represent 10.02% of the Issuer's outstanding shares of common stock. The percent of class is based on shares outstanding as of December 31, 2013, as provided by the Issuer.
