- (1) Award of restricted stock units which represents a hypothetical interest in Carnival plc ordinary shares, which will vest on the third anniversary of the grant date. The restricted stock units will accumulate dividend equivalents and may only be settled in shares.

- (2) The grant date is December 19, 2008. The grant was approved by the Compensation Committee on December 19, 2008 as a total value to be received in the form of restricted shares. The Compensation Committee also approved that the number of shares was to be determined by taking the higher of the average closing price of the period from December 12-17, 2008 and the period from December 19-24, 2008. The final price to determine the number of shares was established on December 24, 2008.
