(1) The common shares of beneficial interest were sold pursuant to a 10b5-1 plan in order to pay estimated tax obligations resulting from the vesting of 500 restricted share units on May 15, 2013.

(2) The reported amount consists of 3,630 restricted share units and 1,530 common shares of beneficial interest. The restricted share units are to be settled in an equal number of common shares of beneficial interest upon vesting. On May 15, 2013, 500 restricted share units vested and were settled in common shares of beneficial interest, of which 234 were sold as described in the preceding footnote and 266 are included in the reported amount.
