- (1) The common shares of beneficial interest were sold pursuant to a 10b5-1 plan in order to pay estimated tax obligations resulting from the vesting of 360 restricted share units on August 4, 2013.
- The reported amount consists of 3,270 restricted share units and 1,725 common shares of beneficial interest. The restricted share units are to be settled in an equal number of common shares of beneficial interest upon vesting. On August 4, 2013, 360 restricted share units vested and were settled in common shares of beneficial interest, of which 195 are included in the reported amount and 165 were sold pursuant to a 10b5-1 plan in order to pay estimated tax obligations that resulted from such vesting.
