(1) Restricted share units that vest on January 16, 2019. The reporting person elected to receive 50% of the underlying common shares (1,402 shares). Receipt of the remaining common shares has been deferred. Distribution of the deferred common shares will be made on the 10th business day of January of the year following the reporting person's retirement from the Board.

(2) Includes restricted share units and dividend equivalents thereon.
