Grant of restricted share units (RSUs) which vest in three equal installments on February 6, 2020, 2021 and 2022. RSU holders are entitled to receive dividend equivalents, exempt from line item reporting under SEC Rule 16a-11, to the same extent dividends are paid on common shares.
