(b) Effective August 6, 2009, Mr. C. Thomas McMillen resigned from his position as Vice-Chairman and as a member of the Board of Directors (the “Board”) of Fortress International Group, Inc. Such consulting agreement will continue to be in full force and effect by its terms following the resignation of Mr. McMillen.
