**Copart, Inc.'s Annual Meeting of Stockholders will be held on December 5, 2012 at 14185 Dallas Parkway, Suite 300, Dallas, TX 75254, at 9:00 a.m. Central Time.**

**Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.**

**The Board of Directors recommends a vote FOR all the nominees listed in Proposal 1 and FOR Proposals 2 and 3:**

1. Election of Directors: Willis J. Johnson, A. Jayson Adair, Matt Blunt, Steven D. Cohan, Daniel J. Englander, James E. Meeks, Vincent W. Mitz and Thomas N. Tryforos.
2. Advisory (non-binding) vote to approve executive compensation for the year ended July 31, 2012 (say on pay vote).
