For the twelve months ended December 31, 2007 the Company anticipates to incur a loss from continuing operations of approximately \$3.5 million, negative cash flows from operations of about \$2.8 million and an accumulated deficit of approximately \$17.5 as compared to a loss from continuing operations of \$5.6 million, negative cash flows from operations of \$4.3 million and an accumulated deficit of \$13.4 for the twelve months ended December 31, 2006.
