(2) These shares were previously reported as directly beneficially owned but are held by a trust for the benefit of Mr. Nikrant's spouse.

(3) The information in this report is based on a PolyOne Retirement Savings Plan statement as of August 27, 2014. PolyOne common shares are held in a unitized fund that consists of stock and cash. The number of shares and the amount of cash may fluctuate daily depending on plan level activity in the fund. Even though no transaction has occurred, this fluctuation may result in an increase or decrease in the number of shares held since the last report filed by the reporting person.
