- (1) 401(k) Plan: This amount includes shares and dividends acquired during the fiscal year pursuant to the H.B. Fuller Company Thrift Plan.
- (2) 2000 Stock Incentive Plan: This option vests in four equal annual installments beginning on January 17, 2003.
- (3) 2000 Stock Incentive Plan: This option vests in four equal annual installments beginning on December 9, 2003.
- (4) Deferred Compensation Plan: These units convert into shares of common stock on a 1-for-1 basis.
- (5) Deferred Compensation Plan: Units convert into shares of common stock upon the earlier of certain termination events as specified in the Key Employee Deferred Compensation Plan or such earlier date as selected by the participant.
- (6) 2000 Stock Incentive Plan: This option vests in four equal annual installment beginning on December 3, 2004.
- (7) 2000 Stock Incentive Plan: This option vests in four equal annual installments beginning on December 2, 2005.
- (8) Key Employee Deferred Compensation Plan Dividend Reinvestment: This amount includes stock units acquired pursuant to a dividend equivalent feature of the Key Employees' Deferred Compensation Plan.
