Patterson Foundation ("WJPFND"), which bought 2,100 shares, John H. Scully ("JHS"), who bought 1,200 shares, William E. Oberndorf ("WEO"), who bought 17,000 shares, and William J. Patterson ("WJP"), who bought 100 shares.
 (1) Due to the purchases causing this filing and related filings today, 13,949,784 shares of the issuer's common stock are owned directly by SPO Partners II, L.P. ("SPO Partners"), and may be deemed to be indirectly beneficially owned by (i) SPO Advisory Partners, L.P. ("SPO Advisory"), the sole general partner of SPO Partners, (ii) SPO Advisory Corp. ("SPO Corp."), the sole general partner of SPO Advisory, and (iii) JHS, WEO, and WJP, the three controlling persons of SPO Corp. Additionally, 721,530 shares of the issuer's common stock are owned directly by SF Partners, and may be deemed to be indirectly beneficially owned by (i) SF Advisory Partners, L.P. ("SF Advisory"), the sole general partner of SF Partners, (ii) SPO Corp., the sole general partner of SF Advisory, and (iii) JHS, WEO & WJP, the three controlling persons of SPO Corp.
 (2) Additionally, as a result of the purchases causing this filing and related filings today, PSF owns 278,100 shares and WJPFND owns 50,800 shares. Additionally, JHS owns 17,500 shares in his IRAs, which are self-directed. Additionally, WEO owns 17,000 shares in
