Unilever NV announces that on 4 September 2007 it purchased 369,477 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.170 and euro 22.550 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 6,567 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 91,014,289 Unilever NV ordinary shares in treasury, and has 1,623,713,411 Unilever NV ordinary shares in issue (excluding treasury shares).
