Unilever NV also announces that 664,407 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,044,184 Unilever NV ordinary shares in treasury and has 1,599,683,516 ordinary NV shares in circulation.
