Unilever NV announces that on 21 November 2007 it purchased 250,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 23.650 and euro 23.930 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 43,996 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, hold 115,348,609 Unilever NV ordinary shares in treasury and has 1,599,379,091 ordinary NV shares in circulation.
