On October 9, 2002, the Registrant filed with the Securities and Exchange Commission a Registration Statement on Form S-8 (Registration Statement No. 333-100433) (the "Form S-8") registering 4,000,000 shares of the Registrant's Common Stock, \$0.01 par value (the "Shares"), to be issued to participants under the Registrant's Employee Stock Purchase Plan (the "Plan"). The Plan was terminated after an aggregate of 525,245 Shares were issued to participants under the Form S-8.
