On August 9, 2006, Crane Co. issued a press release announcing that it had entered into an agreement to purchase all of the capital stock of Noble Composites, Inc. (Noble), a privately held company specializing in the manufacture and sale of premium, high-gloss finished composite panels used by motorhome and travel trailer manufacturers for a purchase price of \$72 million in cash, subject to normal closing adjustments. Closing of the transaction will occur after expiration of the applicable waiting period under the Hart-Scott-Rodino Antitrust Improvements Act.
