On March 8, 2010, Kim C. Goodman, a member of the Board of Directors (the Board) of AutoNation, Inc. (the Company), informed the Company that, in light of her promotion and the associated responsibilities at American Express Company (American Express), she will not stand for re-election at the Company's 2010 Annual Meeting of Stockholders (the Annual Meeting), which is scheduled to be held on May 5, 2010.
