On July 1, 2011, IF Bancorp, Inc. (the Company), the proposed holding company for Iroquois Federal Savings and Loan Association (the Association), issued a press release announcing that the Company expects that the Association's conversion will close on Thursday, July 7, 2011, and that shares of IF Bancorp, Inc. common stock will begin trading on Friday, July 8, 2011, on the NASDAQ Capital Market under the symbol IROQ. On June 30, 2011, the Association's members approved the plan of conversion and the establishment and funding of a charitable foundation, Iroquois Federal Foundation, Inc.
