As you know, American is announcing today some exciting news that will begin the next chapter in the history of our great airline. After many months of careful analysis, we have come to the conclusion that a merger with US Airways will give our people, our customers and our shareholders the most value, and create the best future for our company and our people.

I think you will agree there are many benefits to this combination – an enhanced network and a path to sustainable profitability being among them. Creating this new American will better serve our customers, helping us to effectively compete and win against industry peers, and allow us to continue to invest in our products and people.

We are particularly pleased that through this process, we were able to reach the four-party Memorandum of Understanding that helped us gain insight into how a combined airline would affect our pilots, and will help the transition and integration be as seamless as possible for our pilots. With approval of the merger and our Plan of Reorganization, we will be in a position to quickly share some of the anticipated benefits of the merger with our pilots, which is why we are also pleased that we were able to recently reach agreement on the \$87 million in specific contractual adjustments called for in the MOU. We expect to receive government and US Airways stockholder approval of the merger and Bankruptcy Court approval of our Plan of Reorganization in the third quarter of 2013, at which point the MOU will become effective.

This merger represents what I hope will be a brighter future for our company and our pilots. I look forward to continuing to work with you as we begin the transition toward a stronger American, and I thank you for your efforts to conclude multiple and complex agreements during this unprecedented time.
