On October 31, 2013, Western Digital Corporation, a Delaware corporation, issued a press release announcing the pricing of the previously announced offering of 10,869,566 shares of its common stock by Hitachi, Ltd. (the Selling Stockholder ), at a price to the public of \$67.00 per share. The Selling Stockholder has granted the underwriters of the offering an option to purchase up to an additional 1,630,434 shares.
