<b>Underwriters option to purchase additional shares:</b>	725,806 shares
<b>Common stock outstanding after this offering:</b>	28,140,212 shares (or 28,866,018 shares if the underwriters exercise in full their option to purchase additional shares)
<b>Expected initial public offering price per share:</b>	Between \$19.00 and \$20.00 per share
<b>Net Proceeds:</b>	We estimate that the net proceeds from our issuance and sale of 4,838,710 shares of our common stock in this offering will be approximately \$84.7 million, based on an assumed initial public offering price of \$19.50 per share (the midpoint of the expected price range for the offering), after deducting underwriting discounts and commissions and estimated offering expenses payable by us. If the underwriters exercise in full their option to purchase additional shares, we estimate that the net proceeds from this offering will be approximately \$97.9 million.
