- (1) The shares represent restricted stock units that were received as an award, for no consideration. The restricted stock unit shall vest as to 33.36% of the shares on March 18, 2010 and then as to 16.66% each six months thereafter for the following two years such that the restricted stock unit is fully vested on the three year anniversary of the date of grant.
 - (2) Includes 948, 397 and 2,029 shares purchased pursuant to the Issuer's Employee Stock Purchase Plan on February 29, 2008, August 29, 2008 and February 27, 2009, respectively.
 - (3) The shares are held by the Shannon Revocable Trust, dated 9/24/1997, of which the Reporting Person is trustee.
 - (4) The option shall vest as to 33.36% of the shares on March 18, 2010 and then 8.33% each quarter for the following two years such that the option shall be fully vested on the three year anniversary of the date of grant.
