- Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on December 14, 2009, Mr. Montague elected to receive 50% of his 2010 cash retainer and 2010 meeting fees in Endo common stock. At the time that the retainer and meeting fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer and meeting fees are payable to Mr. Montague in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors and Audit Committee, and the amount reported on this Form represents Mr. Montague's second quarter 2010 retainer and meeting fees. Under the Endo Pharmaceuticals Directors Deferred Compensation Plan, also on December 14, 2009, Mr. Montague elected to defer receipt of all of these shares.
- This number represents (i) 4,843 restricted stock units and (ii) 4,700 shares of common stock, of which 2,691 has been deferred under the Endo Pharmaceuticals Directors Deferred Compensation Plan. Mr. Montague's beneficial ownership disclosed in this table excludes all shares held by Mr. Montague indirectly, including shares underlying stock options.
