(1) Restricted stock grant under the 2008 Performance Plan of The Goodyear Tire & Rubber Company. The shares of common stock will vest on October 5, 2013.

Performance Share Unit Grant of a maximum of 11,038 units (150% of the base number of Units granted) under the 2008 Performance Plan, contingently payable (to the extent earned) 100% in shares of Common Stock, in February, 2013. The grantee may elect to defer (in Common Stock equivalents) all or a portion of the grant earned. Amounts deferred will be paid in shares of Common Stock. The number of Units paid, which can be zero to 11,038 Units, depends 50% on the attainment of a net income target and 50% on the attainment of a cash flow target over a 1-year period ending December 31, 2010.

(3) Non-Qualified Stock Option in respect of shares of common stock granted under the 2008 Performance Plan.

(4) The option vests and becomes exercisable in 25% increments over four years commencing one year after the date of grant.
