- (1) The restricted stock units will vest at a rate of 25% annually on August 2 from the years 2012 through 2015.

The number of performance-based restricted stock units that the executive officer will receive will be determined at the end of the 3-year performance period (January 1, 2011 to December 31, 2013) and will be dependent upon the achievement of cumulative 3-year EPS and average return-on-equity performance metrics previously approved by the Compensation and Human Resources Committee. The target number of performance-based restricted stock units is 21,300.
- (3) The stock options vest at a rate of 25% annually on August 2 from the years 2012 through 2015.
