- (1) Pursuant to the Endo Health Solutions Directors Stock Election Plan, on December 10, 2012, Mr. Kimmel elected to receive 100% of his 2013 cash retainer fees and 100% of his Chairman fees in Endo common stock. At the time that the retainer and Chairman fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer and Chairman fees are payable to Mr. Kimmel in consideration of his services on the Endo Health Solutions Inc. Board of Directors for the first quarter 2013. Under the Endo Health Solutions Inc. Deferred Compensation Plan, also on December 10, 2012, Mr. Kimmel elected to defer receipt of all of these shares.
- (2) This number represents (i) 165,000 shares of common stock held in trusts for which Mr. Kimmel serves as trustee and as to which shares Mr. Kimmel holds either the sole or the shared power of disposition and power to vote, (ii) 6,515 restricted stock units and (iii) 45,009 shares of common stock, of which 38,487 have been deferred under the Endo Health Solutions Directors Deferred Compensation Plan.
