On July 29, 2011, the reporting person was granted 25,000 performance share units (PSUs) under the Company's 2008 Incentive Compensation Plan. Each PSU represented a contingent right to receive one share of common stock. As previously reported, on June 14, (1) 2012, the pre-established performance goal for this award was met and 50% of the PSUs vested immediately. The remainder of PSUs vested on July 29, 2013.
