- (1) Of the 40,400 shares sold, (a) 32,400 were owned by Mr. Marr directly and (b) 8,000 were owned by a partnership in which Mr. Marr is the general partner and is deemed to have sole voting and investment power.
 - (2) On March 13, 2013, Mr. Marr filed a Form 4 that incorrectly stated the sales price at \$59.33. Mr. Marr's sold the shares at an average price of \$58.33.
Mr. Marr's ownership includes: (1) direct ownership of 419,194 shares; and (2) indirect ownership of (a) 43,000 shares held in a descendants trust in which Mr. Marr is deemed to have shared voting power, and (b) 135,777 shares held in a partnership in which Mr. Marr is deemed to have sole voting and investment power. The partnership is owned 99% by a trust in which Mr. Marr's children are the beneficiaries and 1% by the general partner.
