- (1) On February 11, 2013, the reporting person was granted a target of 26,045 shares of restricted stock units subject to satisfaction of pre-determined, performance-based vesting criteria. On February 3, 2015, the Company's Board of Directors determined that those performance criteria for the restricted stock units had been satisfied, which resulted in 47,515 additional shares being achieved and
