One-third of the 6,890 performance share units granted to Mr. Parham vested on March 18, 2013, an additional one-third vested on February 15, 2014 and the remaining one-third will vest on February 15, 2015. In order for the remaining performance share units to vest on February 15, 2015, Mr. Parham must be an employee of the Issuer on such date.
