(1) The reporting person is the sole general partner of the limited partnership; two trusts (of which family members of the reporting person are sole beneficiaries and the reporting person is sole trustee) each own a 49.5% limited partner interest in the limited partnership. The reporting person disclaims beneficial ownership of the Class P common stock held by the limited partnership except to the extent of his pecuniary interest therein.
