Pursuant to the non-qualified deferred compensation plan, payouts can occur for up to 15 years. Amounts held in the phantom stock accounts would be amortized over that period unless directed otherwise by the participant. Each share of VVC phantom stock/phantom units is the equivalent of one share of VVC common stock.
