This is a transaction required to satisfy applicable federal and state income tax withholding requirements. On January 2, 2015, restrictions were released on 20,400 shares of Performance Accelerated Restricted Stock (granted on January 28, 2010 for 8,400 and January 26, 2012 for 12,000) upon Mr. Conschafter's retirement. As required by the 1995 long-Term Incentive Plan, 9,223 shares of Voting Common Stock (no par value) were withheld for tax withholding purposes. As a result of these transactions, Mr. Conschafter additionally will receive a certificate for 11,177 shares of unrestricted Voting Common Stock (no par value).

(2) Additionally, 2,318 derivative Voting Common Stock (no par value) shares are held directly under the Supplemental 401(k) plan.
