April 2017 Orders Comments

Emerson trailing three-month orders increased 2 percent. Underlying orders increased 6 percent excluding unfavorable currency translation of 4 percent. Underlying growth was up mid-single digits in both the Automation Solutions and Commercial & Residential Solutions platforms.
