- On May 21, 2008 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 954 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest (1) in two equal annual installments on the first and second anniversary of the date of grant. On May 21, 2009, 477 shares of the originally granted RSAs vested, of which 141 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
