(c). Bonnie F. McCausland had sole power to vote or to direct the vote, and sole power to dispose or to direct the disposition of, 41,500 shares of the issuer's Common Stock. Mrs. McCausland had shared power to vote or to direct the vote, and/or shared power to dispose or to direct the disposition of, 7,149,860 shares of the Common Stock, which included 35,470 shares held by a charitable foundation (the Foundation) of which Mrs. McCausland is an officer and director.
