The aggregate number of shares to which this Schedule 13G relates is 275,242 shares which is comprised of 210,688 shares of common stock (cusip 859166100) and 64,554 warrants (cusip 859166118), representing 9.51% of the 2,893,014 shares outstanding. This latter number is arrived at by adding the number of shares outstanding as reported in the issuer's most recent 10-Q filing for the quarterly period ended 9/30/2006 (2,828,460) plus the warrants issued to the reporting person (64,554).

Note 1.
