## Item 1. Security and Issuer

This Amendment No. 6 to Schedule 13D is being filed by West Face Capital Inc. ("West Face") and Gregory A. Boland ("Mr. Boland") (collectively, the "Reporting Persons"), pursuant to §240.13d-2(a), to amend the Schedule 13D filed on February 23, 2012 ("Initial Schedule 13D") as amended by Amendment No. 1 filed on May 18, 2012, Amendment No. 2 filed on August 15, 2013, Amendment No. 3 filed on August 28, 2014, Amendment No. 4 filed on September 8, 2014 and Amendment No. 5 filed on August 14, 2015 (Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4 and Amendment No. 5, together with the Initial Schedule 13D, the "Amended Schedule 13D") relating to the Common Shares, no par value (the "Shares"), of SunOpta Inc. (the "Issuer"), whose principal executive offices are located at 2838 Bovaird Drive West, Brampton, Ontario L7A 0H2, Canada. Except as set forth below, all Items of the Amended Schedule 13D remain unchanged. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Amended Schedule 13D.

## Item 5. Interest in Securities of the Issuer

Item 5 of the Amended Schedule 13D is hereby amended and restated in its entirety as follows:

(a, b) The aggregate number of Shares and the percentage of total outstanding Shares beneficially owned by the Reporting Persons as of September 30, 2015 is set forth below:

\*\* This figure is based upon information from the Issuer that, upon the closing on September 30, 2015 of a public offering of Shares by the Issuer, there were 85,333,892 Shares outstanding.

(c) On September 25, 2015, the Reporting Persons purchased 1,001,643 Shares in the open market, including (i) 200,000 Shares at a purchase price of \$7.33 per Share and (ii) 801,643 Shares at a weighted average purchase price of \$5.5089 per Share, with the actual prices ranging from \$5.43 to \$5.63, inclusive.

On September 28, 2015, the Reporting Persons purchased 500,000 Shares in the open market at a weighted average purchase price of \$5.0205 per Share, with the actual prices ranging from \$4.97 to \$5.10, inclusive.

In addition, the Reporting Persons purchased 3,400,000 Shares directly from an underwriter in connection with a public offering of Shares by the Issuer that closed on September 30, 2015, at a purchase price of \$6.00 per Share.

For the transactions reported with a weighted average price, the Reporting Persons undertake to provide upon request by the Commission staff, the Issuer, or a security holder of the Issuer, full information regarding the number of shares purchased at each separate price.
