This Schedule 13G is being filed by Alden Global Capital LLC (the "Reporting Person") to report shares of Common Stock (as defined herein) and warrants that are exercisable into Common Stock ("Warrants") held for the accounts of Alden Global BPI Fund, Ltd., an exempted company organized under the laws of the Cayman Islands, ("Alden Global BPI"), Alden Global Opportunities Master Fund, L.P., an exempted limited partnership organized under the laws of the Cayman Islands, ("Alden Global Opportunities"), Dungan Partners, L.P., a limited partnership organized under the laws of Jersey (Channel Islands), ("Dungan Partners"), and Turnpike Limited, an exempted company organized under the laws of the Cayman Islands (together with Alden Global BPI, Alden Global Opportunities and Dungan Partners, the "Alden Funds"). The Reporting Person serves as investment adviser to each of the Alden Funds and, in such capacity, exercises voting and dispositive power over the shares of Common Stock and Warrants held for the accounts of the Alden Funds.

During 2015, the Reporting Person replaced Alden Global Capital Limited as the investment adviser for a number of private funds, including the Alden Funds, and terminated its sub-advisory agreement with Alden Global Capital Limited. In connection with these changes, Alden Global Capital Limited ceased to provide services to the Alden Funds and, accordingly, is no longer a Reporting Person. In consideration of this change, the Reporting Person qualifies to file on Schedule 13G pursuant to Rule 13d-1(b) under the Act and, accordingly, has filed this Schedule 13G pursuant thereto.

This amount includes: (A) 242,116 shares of Common Stock and 10,171 shares of Common Stock obtainable upon exercise of Warrants held for the account of Alden Global BPI; (B) 3,466,325 shares of Common Stock and 102,742 shares of Common Stock obtainable upon exercise of Warrants held for the account of Alden Global Opportunities; (C) 102,958 shares of Common Stock and held for the account of Dungan Partners and (D) 1,233,273 shares of Common Stock and 36,961 shares of Common Stock obtainable upon exercise of Warrants held for the account of Turnpike Limited.

The Reporting Person may be deemed to beneficially own approximately 7.1% of the shares of Common Stock outstanding. (This is based on the sum of 72,898,234 Shares outstanding plus 149,874 shares of Common Stock the Reporting Person has the right to acquire upon exercise of Warrants.
