**TURKCELL INFORMED ABOUT THE DEVELOPMENT REGARDING TELSİM  
LAWSUIT AGAINST TURKCELL**

As we have announced on August 29, 2005, Telsim initiated a lawsuit claiming that, Turkcell has not applied the reference interconnection rates determined by Telecommunications Authority, and has charged interconnection fees exceeding the ceiling prices approved by Telecommunications Authority and requested an injunction to be applicable starting from August 1, 2005, to cease this practice and requested collection of its damages totaling to TRY26.1 million (equivalent to US\$19.6 million as of April 7, 2005) including principal, interest and penalty on late payment. On September 8, 2005, we also announced that the Istanbul 10<sup>th</sup> Commercial Court decided to reject Telsim's request of injunction regarding this issue.

We have been informed that the Istanbul 10<sup>th</sup> Commercial Court rejected this case that has been initiated by Telsim against our Company.

We hereby confirm that the above-mentioned explanations are furnished as per the provisions of the Communiqué Serial no VIII/39, that they reflect all information we have gathered so far, that they are in accordance with our corporate documents, that we have used all endeavours to collect the complete and true related information and that we assume the responsibility for this disclosure.
