- (1) On December 4, 2007, INVESCO PLC effected a redomicile to Bermuda pursuant to a U.K. Scheme of Arrangement under which shareholders received Common Shares in Invesco Ltd., the new Bermuda parent Company, in exchange for their Ordinary Shares, par value \$0.10 per share in INVESCO PLC. Following the redomicile, Invesco Ltd. effected a one-for-two reverse stock split, such that shareholders now hold Common Shares, par value \$0.20 per share.
  - (2) Shares were withheld from the total number that vested pursuant to a Deferred Share Award - Time Vesting with respect to 6,464 Common Shares in Invesco Ltd. The vesting was previously reported on a Form 4 filed by the reporting person on December 4, 2007.
  - (3) Includes 5,697 Common Shares subject to a Restricted Share Award.

### Remarks:

This Form 4 reports the withholding on December 13, 2007 of certain shares to pay taxes in connection with the vesting of certain Deferred Share Awards - Time Vesting on November 30, 2007. As explained in the footnotes hereto, on December 4, 2007, INVESCO PLC effected a redomicile to Bermuda pursuant to a U.K. Scheme of Arrangement under which shareholders received Common Shares in Invesco Ltd., the new Bermuda parent company, in exchange for their Ordinary Shares, par value \$0.10 per share, in INVESCO PLC. Following the redomicile, Invesco Ltd. effected a one-for-two reverse stock split, such that shareholders now hold Common Shares, par value \$0.20 per share.
