Thus the reporting person will receive 1,667 shares of common stock of the issuer (or cash equal to the value of common stock on the settlement date, in the sole discretion of the Company) on each of January 19, 2010 and 2011 and 1,666 shares of common stock of the issuer (or cash equal to the value of the common stock on the settlement date, in the sole discretion of the Company) on January 19, 2012, provided the reporting person remains an employee of the issuer on those dates.
