## **CELLCOM ISRAEL ANNOUNCES legal actions against golan telecom**

**Netanya, Israel – July 12, 2016** – Cellcom Israel Ltd. (NYSE: CEL) (TASE: CEL) (hereinafter: the "Company") announced that following the Company's previously reported notice to Golan Telecom that its hosting agreement with Hot Mobile Ltd., another Israeli cellular operator, constitutes material breaches of the Share Purchase Agreement and National Roaming Agreement between the Company and Golan Telecom, and Golan Telecom's subsequent rejection of said notice, the Company commenced legal actions against Golan Telecom, including a request for an interim injunction against the consummation of the Golan Telecom – Hot Mobile agreement.
