**Item 5.07. Submission of Matters to a Vote of Securityholders**

On September 16, 2010, the Annual Meeting of Stockholders of Transcontinental Realty Investors, Inc. ( TCI or the Issuer or the Registrant ) was held following a solicitation of proxies pursuant to a Notice of Annual Meeting and related Proxy Statement dated August 6, 2010 distributed in accordance with the requirements of Regulation 14A under the Securities Exchange Act of 1934, as amended (the Exchange Act ). On the record date of August 4, 2010, 8,113,669 shares of Common Stock were outstanding with each share being entitled to cast one vote.

At the Annual Meeting, which involved the election of directors, the following named persons received the number of votes cast for, against or withheld, as well as the number of abstention and broker non votes:

All of the nominees named above, each of which is currently a director of the Registrant, were elected at such Annual Meeting.

The only other matter presented at the Annual Meeting was the ratification of the appointment of Farmer, Fuqua & Huff, P.C. as the independent registered public accounting firm for the Registrant for the fiscal year ending December 31, 2010 and any interim period. A total of 7,449,543 votes were cast for, 4,803 votes were cast against and 12,933 votes abstained from voting with respect to such proposal.
